A RESOLUTION APPROVING PLANS AND SPECIFICATIONS; AUTHORIZING AWARD OF PUBLIC WORKS CONTRACT; AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the plans and specifications for the construction of Replacement of Dama'ged Sidewalk, Curb/Gutter City Wide Group C-24 [Project], filed in the office of the City Clerk as Document No. w. o. 590020 , are approved.
- 2. That, after advertising for bids in accordance with law, the City Manager is authorized to award the Project contract to the lowest responsible and reliable bidder in an amount not to exceed \$247,823, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. Authorizing an increase in the amount of \$56,007 in the Fiscal Year 2004 CIP budget in CIP No. 59-002.0, Sidewalks Replacement and Reconstruction, in Street Division Resurfacing Fund No. 104402.
- 4. That the expenditure of a total amount not to exceed \$303,830 from CIP No. 59-002.0, Sidewalks Replacement and Reconstruction, from TransNet Fund No. 30300 (\$247,823) and Street Division Resurfacing Fund No. 104402 (\$56,007) is authorized solely and exclusively for the purpose of providing funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

5. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
