WHEREAS, the Grand Avenue Median Improvement Project is the current phase of the Pacific Beach Streetscape Improvements, CIP No. 39-224.0 and construction is nearly complete; and

WHEREAS, the improvement plan called for a pedestrian activated traffic signal to be installed at Grand and Figueroa Boulevard to provide for a safe crossing of Grand Avenue which would meet ADA requirements; and

WHEREAS, there have been \$50,000 in unanticipated costs related to installation of this traffic signal; and

WHEREAS, the \$50,000 needed for completion of the project is being made available by Council District 2 in their FY 2004 CDBG Funding dedicated to making ADA improvements and by the Community & Economic Development Department's Disability Services; and

WHEREAS, the project will be completed and the pedestrian activated traffic signal energized as soon as this action is approved; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the City Manager, or his designee, is authorized to accept \$50,000 in
 Community Development Block Grant [CDBG] funds for overage due to the
 provision of necessary ADA improvements in the Grand Avenue Median
 Improvements Project.

- 2. That the increase of \$50,000 to the FY 2004 CIP Budget for CIP 39-224.0, Pacific Beach Streetscape: Grand Avenue Median Improvements is authorized.
- 3. That the City Auditor and Comptroller is authorized to appropriate and expend an additional \$50,000 in CIP No. 39-224.0, for the purpose of completing construction of the Grand Avenue Median Improvements Project ADA requirements.
