
WHEREAS, the contract is currently in an amount not to exceed \$800,000; and

WHEREAS, additional services from the Firm are now needed by the City relating to negotiations and the conduct of litigation; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney is hereby authorized and directed to execute an amendment to the retention agreement with the Firm for an additional amount not to exceed \$500,000, for a total contract amount not to exceed \$1.3 million.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$500,000 from Fund 81140, Dept. 81140, Org. No. 3502, Object Account 4141, Job Order 811401, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
