 Improvements Program.
- 2. That the City Auditor and Comptroller is authorized to increase the Fiscal Year 2004 Capital Improvements Program budget by \$10,000 in CIP No. 29-866.0, Montgomery-Waller Community Park Sports Field Lighting, Fund No. 18539, Community Development Block Grant Fund.
- 3. That the City Auditor and Comptroller is authorized to transfer \$10,000 from Fund No. 18539, Community Development Block Grant Fund to CIP No. 29-866.0, Montgomery-Waller Community Park Sports Field Lighting, for the purpose of park planning services.

4. That the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$10,000 from CIP No. 29-866.0, Montgomery-Waller Community Park Sports Field Lighting, for the purpose of initiating planning and preliminary design.
