BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate an amount not to exceed \$16,000 from Council District 2 Community Development Block Grant [CDBG] Funds into CIP No. 39-216.0, Washington/Goldfinch Intersection Improvements.

BE IT FURTHER RESOLVED, that a \$229,000 increase in the Fiscal Year 2004 Capital Improvements Program Budget in CIP No. 39-216.0, Washington/Goldfinch Intersection Improvements, Fund No. 30244, Capital Improvements Fund is authorized.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend an additional amount not to exceed \$229,000 in CIP No. 39-216.0, Washington/Goldfinch Intersection Improvements, Phase 2, solely and exclusively for the purpose of constructing the Washington/Goldfinch Intersection Improvements, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit in the City treasury.
