BE IT FURTHER RESOLVED, that the City Manager is authorized to increase the Fiscal Year 2004 Budget in CIP No. 68-010.0, Traffic Signals-Citywide, Fund 63022, Private and Developer Contributions CIP in the amount of \$335,968.88.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend \$335,968.88, from Fund 63022, Private and Developer Contributions CIP, CIP No. 68-010.0, Traffic Signals-Citywide, for the design and construction of new traffic signals at Qualcomm Way and Friars Road Eastbound Ramps and Qualcomm Way and Friars Road Westbound Ramps.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized, upon advice of the administering department, to return excess budgeted funds, if any, to Fund 63022, Private and Developer Contributions CIP, Job Order No. 960544.
