2. That the Council finds that the election results of February 18, 2004, are valid and

binding in accordance with the procedures so adopted by Resolution No. 98703.

3. That the Redevelopment Agency of the City of San Diego is directed to consult

with and obtain the advice of the PAC pursuant to the provisions of the California Community

Redevelopment Law (California Health and Safety Code section 33000 et seq.).
