BE IT RESOLVED, by the Council of the City of San Diego, that the plans and specifications for the construction of the Central Area Police Station Expansion [Project], filed in the office of the City Clerk as Document No. Wio:360450, are approved.

BE IT FURTHER RESOLVED, that the City Manager is authorized to execute the Project contract with the lowest responsible and reliable bidder, John Carey Construction, in an amount not to exceed \$918,900 provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate \$1,021,103 in Fund No. 19364 and \$26,361 in Fund No. 18707 for CIP No. 36-045.0, Police Crime Laboratory Expansion.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,021,103 from Fund No. 19364 and \$26,361 from Fund No. 18707 for CIP No. 36-045.0, Police Crime Laboratory Expansion, is authorized solely and exclusively for the purpose of providing funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend \$26,361 of interest earnings from Fund No. 19364 to reimburse Fund No. 18707, contingent upon receipt of authorization of granting agency to use grant interest on Project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
