A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO ACCCEPTING A REPAYMENT OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS IN THE AMOUNT OF \$25,000 FROM THE REDEVELOPMENT AGENCY AND PROGRAMMING THE REPAYMENT TO FUND A PSYCHIATRIC EMERGENCY RESPONSE TEAM CLINICIAN TO SERVE AS PART OF THE HOMELESS OUTREACH TEAM.

WHEREAS, the City of San Diego [City] has developed the Homeless Outreach Team [HOT] Program; and

WHEREAS, the focus of the program is to address the causes of homelessness on a caseby case basis, treat the homeless as individuals, and direct them to appropriate service providers by having trained individuals available to interact on an immediate basis; and

WHEREAS, an essential component of the HOT Program is the Psychiatric Emergency Response Team [PERT] clinician, who provides specialized mental health services; and

WHEREAS, these services are provided through a contract between PERT, Inc. and the City of San Diego; and

WHEREAS, additional funding is required to maintain the current level of service through the balance of the fiscal year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego the following:

- That the City Council accept repayment of previously allocated Community
 Development Block Grant Funds in the amount of \$25,000 to the City from the Redevelopment
 Agency.
- 2. That the City Council program the funds for a PERT clinician to serve as part of the HOT program (Fund No. 18539).
