A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING A LOAN REPAYMENT OF \$125,000 FROM THE NORTH BAY REDEVELOPMENT PROJECT AREA, APPROPRIATING THE \$125,000 AS A LOAN TO THE REDEVELOPMENT AGENCY FOR USE IN THE GRANTVILLE REDEVELOPMENT SURVEY AREA

WHEREAS, a feasibility study has been conducted for the Grantville/Mission Gorge

Community to make a preliminary determination of the blighting conditions and potential for a redevelopment project area; and

WHEREAS, the City is desirous of conducting further study of the above community areas to determine whether a redevelopment project or projects would be feasible pursuant to the California Community Redevelopment Law (California Health and Safety Code section 33000 et seq.) within a defined Grantville Redevelopment Survey; and

WHEREAS, the Council has authorized the study of the survey area of a redevelopment project area, and wishes to appropriate sufficient funds to conduct the necessary survey area studies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City accepts the loans Repayment to Fund 18502 [Community Development Block Grant (CDBG)] from the North Bay Redevelopment Project Area in the amount of \$125,000.

2. That the appropriation and transfer of \$125,000 from Fund 18502 (CDBG) as a loan to the Redevelopment Agency to provide funds to the Grantville Redevelopment Survey Area with the loan to be recorded as debt of the Agency to be repaid as soon as practicable from tax increment or other revenues is authorized.
