 - (b) the public will benefit from the vacation through improved utilization of land; and
- (c) the vacations are consistent with the General Plan or an approved Community Plan; and
- (d) the public facility or purpose for which the easements were originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the slope easements located within Lots 1, 2 and 6 of La Jolla Commons Map No. 14466, as more particularly described in the legal descriptions marked as Exhibit "A1," Exhibit "A2," and Exhibit "A3," and shown on Drawing Nos. 19986-1-B, and 19986-2-B,

marked as Exhibit "B-1," and "B-2," and on file in the office of the City Clerk as Document Nos. RR- 299066-1, RR- 299066-2, RR- 299066-3, RR- 299066-4 and RR- 299066, which are by this reference incorporated herein and made a part hereof, is ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.
