1. That the access easement located within Lots 2 and 5 of La Jolla Commons Map No. 14466, as more particularly described in the legal description marked as Exhibit "A4," and shown on Drawing No. 19986-3-B, marked as Exhibits "B3," and on file in the office of the City

Clerk as Document Nos. RR- 299067, and RR- 299067, which are by this reference incorporated herein and made a part hereof, is ordered vacated.

- 2. That the water easement located within Lots 2 and 5 of La Jolla Commons Map No. 14466, as more particularly described in the legal description marked as Exhibit "A5," and shown on Drawing No. 19986-4-B, marked as Exhibits "B4," and on file in the office of the City Clerk as Document Nos. RR-29967-3, and RR-299667, which are by this reference incorporated herein and made a part hereof, is ordered vacated.
- 3. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.


