No. 00104-C, marked as Exhibit "B," and on file in the office of the City Clerk as Document Nos. RR- 299191-1, and RR- 299191-2, which are by this reference incorporated herein and made a part hereof, are ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.


