WHEREAS, Chapter 12, Article 5, Division 10 of the Land Development Code provides a procedure for the abandonment of City-owned easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the abandonment of the Cityowned utility and road easement, to unencumber this property and facilitate development of the site as conditioned in Vesting Tentative Map No. 25674; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the City-owned easement either for which it was originally acquired, or for any other public use of a like nature that can be anticipated; and
- (b) the public will benefit from the abandonment through improved utilization of land; and
- (c) the abandonment is consistent with the General Plan or an approved Community Plan; and
- (d) the public facility or purpose for which the easement was originally acquired will not be detrimentally affected by the abandonment or the purpose for which the easement was acquired no longer exists; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That a portion of the utility and road easement as disclosed by document recorded September 6, 1977 as File/Page No. 77-370114 of Official Records, as more particularly

described in the legal description marked as Exhibit "A," and shown on Drawing No. 20221-B, marked as Exhibit "B," and on file in the office of the City Clerk as Document Nos.

RR-299206-1, and RR-2992062, which are by this reference incorporated herein and made a part hereof, is ordered abandoned.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.
