BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a phase funded agreement with Wylie Construction, Inc., in an amount not to exceed \$17,107,154 for design-build construction services for the Nobel Athletic Area and North University Branch Library, contingent on City Auditor and Comptroller first certifying that funds necessary for each contract phase are, or will be, on deposit with City Treasurer, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR 299210, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$971,260 from Nobel Athletic Area, CIP No. 29-718.0 and North University Community Branch Library, CIP No. 35-098.0, is authorized for the purpose of funding Phase I (design) of the design-build agreement; and authorizing the expenditure of \$16,135,894 from Nobel Athletic Area, CIP No. 29-718.0 and North University Community Branch Library, CIP No. 35-098.0, for the purpose of funding Phase 2 (construction) of the design-build agreement, contingent upon the following: (1) certification of the required environmental document for the Project; (2) approval of any required discretionary permits for the Project; and (3) the City Auditor and Comptroller first certifying that necessary funds are or will be on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
