RESOLUTION NUMBER R- 299345 ADOPTED ON JUN 1 5 2004

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF MAY 27, 2004 FOR THE BARRIO LOGAN REDEVELOPMENT PROJECT AREA COMMITTEE.

WHEREAS, on October 30, 1989, the Council of the City of San Diego [Council] by Resolution No. R-274651 adopted the Procedure of the Formation of a Project Area Committee [PAC] for the Barrio Logan Redevelopment Project [Project]; and

WHEREAS, on December 8, 2003, the Council by Resolution No. R-298704 amended the Procedure for Formation of a PAC for the Barrio Logan Redevelopment Area; and

WHEREAS, California Community Redevelopment Law [Law] requires that PACs remain in existence for three (3) years from the date of adoption of the redevelopment plan; and

WHEREAS, on December 8, 2003, the Council by Resolution No. R-298706 authorized a one (1) year extension of the PAC and directed Redevelopment Agency staff to notice and conduct an election for the Barrio Logan Redevelopment Area PAC in 2004; and

WHEREAS, the annual election was conducted on May 27, 2004, after notice and according to the Project PAC bylaws and procedures enumerated within the documents approved by the Council; and

WHEREAS, a representative from the City Clerk's office attended the May 27, 2004, election to ensure its validity; and

WHEREAS, the elected members of the Project Area Committee have submitted

information establishing the qualifications of each person relative to district, category or

organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the Barrio Logan Redevelopment Project Area Committee consisting of

persons named on the list of Project Area Committee members receiving the highest number of

votes attached hereto as Exhibit A and incorporated herein by this reference is hereby approved

as constituting a representative Project Area Committee.

2. That the Council hereby concurs that the election results of May 27, 2004 are

valid and binding in accordance with the procedures so adopted by Resolution Nos. R-276892

and R-295698.

That the Redevelopment Agency of the City of San Diego is directed to consult 3.

with and obtain the advice of the PAC and CCAC pursuant to the provisions of the California

Community Redevelopment Law (California Health and Safety Code section 33000 et seq.).
