A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING FUNDING FOR TWO NEW CITY PARKS; NAMELY, FOX CANYON PARK AND HOME AVENUE PARK.

WHEREAS, the proposed Fox Canyon Park is located east of Euclid Avenue, west of Altadena Drive, and south of University Avenue, in the Fox Canyon Neighborhood, adjacent to Auburn Creek, and will provide an approximately two-acre passive use park, which is highly needed in the community as a recreational outlet; and

WHEREAS, the proposed Home Avenue Park is located on the east side of Home Avenue, near the intersection with 47th Street, in the Mid-City area, adjacent to Chollas Creek, and the six acre site will provide approximately two-acres of much needed passive use park land, as well as enhancing a portion of Chollas Creek; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Fiscal Year 2004 Capital Improvements Program Budget is amended by adding CIP No. 298650, Home Avenue Park.
- 2. That the Fiscal Year 2004 Capital Improvements Program Budget for Fund No. 39094, Mid-City Special Park Fees, CIP No. 298650, Home Avenue Park, is amended by increasing the budget amount by \$600,000.
- 3. That the appropriation and expenditure of an amount not to exceed \$600,000 from Fund No. 39094, Mid-City Special Park Fees, CIP No. 298650, Home Avenue Park, is

authorized solely and exclusively for the purpose of providing funds for design contracts and initial environmental studies of Home Avenue Park.

4. That the Fiscal Year 2004 Capital Improvements Program Budget is amended by

adding CIP No. 295960, Fox Canyon Park - Acquisition and Development.

5. That the Fiscal Year 2004 Capital Improvements Program Budget for Fund No.

39094, Mid-City Special Park Fees, CIP No. 295960, Fox Canyon Park – Acquisition and

Development, is amended by increasing the budget amount by \$900,000.

6. That the appropriation and expenditure of an amount not to exceed \$900,000 from

Fund No. 39094, Mid-City Special Park Fees, CIP No. 295960, Fox Canyon Park - Acquisition

and Initial Studies, is authorized solely and exclusively for the purpose of providing funds for

the purposes of acquisition, design contracts, and environmental studies of Fox Canyon Park,

provided that the City Auditor and Comptroller first furnishes one or more certificates certifying

that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.

7. That the City Auditor and Comptroller, upon advice from the administering

department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
