WHEREAS, in connection with its Challenge America: Access to the Arts Program, the National Endowment for the Arts [NEA] has granted \$15,000 [the NEA Grant Funds] to the City of San Diego Commission for Arts and Culture [Commission] to support the Commission's Folk and Traditional Arts Program Website Project [Project]; and,

WHEREAS, the NEA Grant Funds will be used to expand the Commission's existing web pages on the City's website in order to provide a directory of local folk and traditional artists and resources; and,

WHEREAS, the Commission will thereby promote and build public awareness of, and access to, folk and traditional arts in the San Diego region and expand the services that the Commission provides to the local arts community; and,

WHEREAS, as a condition of receiving the NEA Grant Funds the City is required to provide a cash match in the amount of \$15,000 [the Cash Match]; and,

WHEREAS, the NEA Grant Funds and the Cash Match will be used to hire a project coordinator and a web design consultant and to fund any costs which are incurred interdepartmentally for website development in connection with the Project; and,

WHEREAS, the required Cash Match is available in the Commission's FY04 administrative budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Manager, or designee, is authorized to apply for and accept the NEA

Challenge America: Access to the Arts Program grant funds [the NEA Grant Funds] in the

amount of \$15,000 for the Folk and Traditional Arts Program Website Project [Project] in Fiscal

Year 2004 to implement the Project and related activities.

2. That the City Manager, or designee, is authorized to expend the NEA Grant Funds

in an amount not to exceed \$15,000 and matching funds in an amount not to exceed \$15,000, for

a total amount not to exceed \$30,000, solely and exclusively for the Project and related activities,

contingent upon the City Auditor and Comptroller first issuing one or more certificates certifying

that funds necessary for expenditures are, or will be, on deposit with the City Treasurer.
