

ADOPTED ON JUL 27 2004

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Little Italy Association, for administration of Contracts for Goods and Contracts for Services for the Little Italy Maintenance Assessment District for a period of one year in accordance with San Diego Municipal Code section 65.0212, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 299504.

BE IT FURTHER RESOLVED, that the effective date and term of the Agreement is July 1, 2004 through June 30, 2005.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$49,936 (\$19,975 from Fund 70261, Dept. 70261, Org 2000, Acct 4151, J.O. 2000 and \$29,961 from Fund 70261, Dept. 70261, Org 2050 Acct 4151, J.O. 2050), is hereby authorized to provide reimbursement to the Little Italy Association for administration services from July 1, 2004 through June 30, 2005.
