A RESOLUTION PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 APPROVING THE ISSUANCE OF BONDS BY THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO FOR THE ACQUISITION AND REHABILITATION OF HILLSIDE GARDENS APARTMENTS.

WHEREAS, the Housing Authority of the City of San Diego [the Authority] adopted a resolution that constituted a declaration of official intent the issuance of not to exceed \$27 million aggregate principal amount of multifamily housing revenue bonds for the Hillside Gardens Apartments [the Bonds] to finance the acquisition and rehabilitation of approximately 360 units of multifamily rental housing located at the site described in the form of notice of public hearing attached as Exhibit "A" [the Project]; and

WHEREAS, in order for interest on the Bonds to be tax-exempt, Section 147(f) of the Internal Revenue Code of 1986, as amended, requires that issuance of the Bonds be approved by the City Council as the applicable elected representative with respect to the Authority, after a public hearing following reasonable public notice; and

WHEREAS, the purpose of the 147(f) hearing and approval is to notify the public of the potential issuance of bonds and the proposed use of bond proceeds to ensure the use of the proceeds for a public benefit purpose; and

WHEREAS, notice of a public hearing with respect to the proposed issuance of the Bonds was published in a newspaper of general circulation in the City on July 5, 2004; and

WHEREAS, the hearing was held on July 20, 2004, and an opportunity was provided for interested persons to express their views on the issuance of the Bonds and on the nature and location of the Project; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that this City Council, as the applicable elected representative under Section 147(f) of the Code, approves the issuance of the Bonds by the Authority for the Project.

BE IT FURTHER RESOLVED, the City does not warrant the creditworthiness of the Bonds or guarantee, in any way, the payment of the Bonds. No moneys of the City will be pledged or applied to the payment of the Bonds.
