A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO MAKING CERTAIN FINDINGS WITH RESPECT TO THE PAYMENT FOR THE EL CAJON MEDIAN IMPROVEMENTS; ACCEPTING THE TRANSFER OF FUNDS FROM THE REDEVELOPMENT AGENCY IN THE AMOUNT OF \$1,750,000; AMENDING THE CAPITAL IMPROVEMENT PROGRAM BUDGET NO. 39-234.0 TO INCLUDE THE \$1,750,000; AND AUTHORIZING THE TRANSFER OF \$200,000 FROM THE CITY OF SAN DIEGO TO THE GRANTVILLE REDEVELOPMENT SURVEY AREA.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council finds and determines that El Cajon Blvd Median Improvements are of benefit to the Crossroads Redevelopment Project; that the Council finds and determines that no other reasonable means for financing are available to the community; that the Council finds and determines that it will assist in eliminating one or more blighting conditions inside the Project Area; and that the Council finds and determines that it is consistent with the Implementation Plan adopted for the Project by the Agency May 2003, on file as Document No. 00-19174 in the office of the Secretary to the Agency pursuant to California Health and Safety Code Section 33490.
- 2. That the Council accepts the transfer of funds from the Agency in the amount of \$1,750,000.
- 3. That the Council amends the Capital Improvement Program Budget No. 39-234.0 to include the \$1,750,000 in Agency public improvement contributions and remove the continuing appropriations in Council District 7 CDBG finds in the amount of \$200,000.

- That the Council authorizes the transfer of \$200,000 from Council District 7 4. CDBG funds to the Redevelopment Agency, as an interest bearing loan to be used in the Fiscal Year 2005 project budget to fund plan adoption activities for the Grantville Redevelopment Survey Area.
- That the City Auditor is directed to record the \$200,000 transfer from the City as 5. an interest bearing loan from the City of San Diego to be repaid as soon as practicable from tax increment or other appropriate revenues.
