Jackson filed in the Office of the County Clerk recorded October 7, 1925 in Book 1121, Page 254 of Deeds, as more particularly described in the legal description marked as Exhibit "A," and shown on Engineering Drawing No. 20236-B, marked as

Exhibit "B," and on file in the office of the City Clerk as Document Nos. RR-299689-, and RR-299689-, which are by this reference incorporated herein and made a part hereof, is ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.


