certifying that the funds necessary for expenditures are, or will be, on deposit with the City

Treasurer.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from

the administering department, is authorized to transfer excess budgeted funds, if any, to the

appropriate reserves.
