A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO APPROVING PLANS AND SPECIFICATIONS;
AUTHORIZING AWARD OF PUBLIC WORKS CONTRACT;
AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the plans and specifications for the "Replacement of Tree Root Damaged Sidewalk, Curb and Gutter City Wide FY 05 – Group-29" [Project], filed in the office of the City Clerk as Document No. W.O. 576510, are approved.


2. That, after advertising for bids in accordance with law, the City Manager is authorized to award the Project contract to the lowest responsible and reliable bidder in an amount not to exceed \$865,500, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the appropriation and expenditure of an amount not to exceed \$865,500 from Street Division Operating Fund 10440, is authorized solely and exclusively for the purpose of funding this contract and related expenses, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds for expenditures are, or will be, on deposit with the City Treasurer.

4. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
