Council hereby approves the recommendations of City Manager's Report No. 04-219 regarding

amendments to the Emergency Medical Services Agreements, in addition to modifications

contained in City Manager's Report No. 04-244 dated NOV 10 2004

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered for and on behalf of the City to execute the Third Amended and Restated Operating Agreement of San Diego Medical Services Enterprise, LLC, thereby extending the existence of

SDMSE from December 1, 2004 until June 30, 2008, unless sooner terminated pursuant to the provisions of the Agreement, the form of which is on file in the office of the City Clerk as

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered for and on behalf of the City to execute the Third Amended and Restated Emergency Medical Services Agreement between SDMSE and the City, thereby extending the Agreement from December 1, 2004 until June 30, 2008, unless sooner terminated pursuant to the provisions of the Agreement, the form of which is on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered for and on behalf of the City to execute the Third Amended and Restated Agreement between SDMSE and the City, thereby extending the Agreement from December 1, 2004 until June 30, 2008, unless sooner terminated pursuant to the provisions of the Agreement, the form of which is on file in the office of the City Clerk as Document No. RR-299840 -3.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered for and on behalf of the City to execute the Third Amended and Restated Agreement between SDMSE and Rural/Metro of San Diego, Inc., thereby extending the Agreement from December 1, 2004 until June 30, 2008, unless sooner terminated pursuant to the provisions of the Agreement, the form of which is on file in the office of the City Clerk as Document No. RR-299840-4

BE IT FURTHER RESOLVED, that the City shall transfer to SDMSE an amount per year for each year of the extension to subsidize the cost of emergency medical and medical

transportation services as a direct result of the Federal or State Government's Medicare/Medi-Cal Fee Reimbursement Reductions in an amount not to exceed \$250,000 per year collectively.

BE IT FURTHER RESOLVED, that City Manager be and is hereby authorized for and on behalf of the City to prepare a lease agreement with SDMSE for property located at Interstate 15 and Aero Drive for ambulance and employee parking.
