A RESOLUTION OF THE CITY OF SAN DIEGO TRANSFERRING AND APPROPRIATING FUNDS FOR CHANGE ORDER NO. 1 REGARDING THE UNDERGROUND STORAGE TANK PROGRAM.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That in accordance with the 2005 Annual Appropriation Ordinance, the City Auditor and Comptroller is authorized and directed to amend the Fiscal Year 2005 Capital Improvement Program budget to increase CIP 33-084.0, Underground Hazardous Materials Storage Tanks, Fund No. 630221, Contributions from the General Fund, by the amount of \$13,336.99.
- 2. That the City Auditor and Comptroller is further authorized to transfer the amount of \$13,336.99 from Fire-Rescue Department, General Fund No. 100, to Fund No. 630221, Contributions from the General Fund.
- 3. That Change Order No.1, dated October 12, 2004, on file with the City Clerk as Document No. RR-299852 , issued in connection with the contract between the City and Silverton General, Inc., for fuel system upgrades at the City's Lifeguard Headquarters, is hereby approved, together with the changes therein set forth, amounting to a net increase in the contract price of \$13,336.99.
- 4. That the City Auditor and Comptroller is further authorized to appropriate and expend an amount not to exceed \$13,336.99 from CIP 33-084.0, Underground Hazardous Materials Storage Tanks, solely and exclusively to provide funds for Change Order No. 1 to the

construction contract with Silverton General, Inc., for upgrades to the fuel system at the City's Lifeguard Headquarters.
