

ORDINANCE NUMBER O- 19441 (NEW SERIES)

ADOPTED ON NOV 14 2005

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENTS EXTENDING THE LONG-TERM WASTE DELIVERY AGREEMENTS WITH SPECIFIED FRANCHISED SOLID WASTE COLLECTION COMPANIES.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. That the City Manager is hereby authorized to execute amendments to the long-term waste delivery agreements with the specified franchised solid waste collection companies listed on Exhibit A attached, to provide for short-term extensions of those agreements to October 31, 2005, under the terms and conditions described in the amendments to those agreements on file in the Office of the City Clerk as Documents No. 00-19441-1 through 00-19441-11

Section 2. That this activity is not subject to CEQA pursuant to CEQA guideline 15061(b)(3) because it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

Section 3. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
