ORDINANCE NUMBER O- 19442 (NEW SERIES)

ADOPTED ON NOV 14 2005

AN ORDINANCE PERMITTING THE SALE OF SURPLUS MOTORCYCLES TO THE CITY OF ENSENADA AND PERMITTING FUNDS FROM THIS SALE TO BE ALLOCATED TO THE UNLICENSED DRIVERS VEHICLE IMPOUND FEES FUND

WHEREAS, the San Diego Police Department has determined that twenty motorcycles described in Attachment A are surplus to the needs of the City; and

WHEREAS, the City of Ensenada has made a formal offer to purchase the twenty motorcycles in Attachment A for use by its police department for \$59,790; and

WHEREAS, in setting the price of \$59,790, for the motorcycles the Police Department has valued each motorcycle in Attachment A by averaging the lowest and highest prices obtained at auction for similar, comparable models; and

WHEREAS, the price of \$59,790 for the twenty motorcycles in Attachment A is \$9,270 above the Kelley Blue Book trade-in value for the motorcycles (per the Kelley Blue Book website, [www.kbb.com](http://www.kbb.com), last visited September 19, 2005); and

WHEREAS, the Unlicensed Drivers Vehicle Impound Fees Fund had recently expended funds to purchase new motorcycles; and

WHEREAS, Section 35 of the Charter of the City of San Diego provides that the City Council shall by ordinance provide for the disposal of surplus personal property belonging to the City of San Diego; and

WHEREAS, Section 22.0506 of the Municipal Code for the City of San Diego provides that property valued at \$10,000 or greater shall be disposed of either at public auction or shall be the subject of sealed bids; and

WHEREAS, the City Council must enact an ordinance in order to permit the proposed sale of twenty motorcycles in Attachment A to the City of Ensenada and exempt the sale from the requirements of Section 22.0506; and

WHEREAS, the City Council for the City of San Diego has previously approved at least one similar sale to the City of Tijuana in Ordinance number O-18832, adopted July 31, 2000; and

WHEREAS, pursuant to Section 22.0506 of the Municipal Code for the City of San Diego, the revenue from sales of surplus property is normally appropriated to the General Fund; and

WHEREAS, the Uninsured Drivers Vehicle Impound Fees Fund has recently been depleted significantly by the purchase of new motorcycles, and permitting the revenue from the sale of the twenty surplus motorcycles in Attachment A should be properly allocated to the Unlicensed Drivers Vehicle Impound Fees Fund and that this transaction should be exempted from Section 22.0506's requirement that the proceeds from surplus property be allocated to the General Fund; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1: That, notwithstanding Section 22.0506 of the Municipal Code, the City Manager is hereby authorized to sell to the City of Ensenada twenty motorcycles described in Attachment A for the prices indicated thereon, for a total of \$59,790.


Section 2. That the City Manager is authorized to take all necessary actions and sign any documentation necessary to complete the sale of the twenty motorcycles to the City of Ensenada.

Section 3. That, notwithstanding Section 22.0506 of the Municipal Code, the \$59,790 from the sale of the twenty motorcycles in Attachment A shall be deposited in the Unlicensed Drivers Vehicle Impound Fees Fund, Fund number 18684, revenue account 78348.

Section 4. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
