AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE THIRD AMENDMENT TO THE CONSULTANT AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND MCGRAW/BALDWIN ARCHITECTS

WHEREAS, on January 13, 2000, the City Manager of the City of San Diego approved a consultant agreement between the City of San Diego and McGraw/Baldwin Architects, on file in the office of the City Clerk as Document No. C-09830, for the schematic design and environmental review of the College/Rolando Library; and,

WHEREAS, on December 20, 2002, the Council of the City of San Diego approved the First Amendment between the City of San Diego and McGraw/Baldwin Architects, on file in the office of the City Clerk as Document No. RR-297408, to provide the necessary professional services to complete the required construction drawings and specifications; and

WHEREAS, on September 22, 2003, the Council of the City of San Diego approved the Second Amendment between the City of San Diego and McGraw/Baldwin Architects, on file in the office of the City Clerk as Document No. RR-298398, to provide for additional design modifications, construction document preparation, and other additional services; and

WHEREAS, the City of San Diego now desires a Third Amendment to the Agreement to increase the additional services and reimbursable expenses budget necessary to modify the construction drawings for vehicular access revisions, requested by the community, and for project value engineering; and

WHEREAS, under San Diego Charter section 99 no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, the Third Amendment to the Agreement with McGraw/Baldwin Architects for professional services required for the construction of the College Rolando Library, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No 20-19443

Section 2. That the expenditure of an amount not to exceed \$47,793 from CIP No. 35-071.0, College/Rolando Branch Library, Fund No. 30244, Dept. No. 30244, Org. No. 106, is authorized to provide funding for the Third Amendment to the Agreement for the College/Rolando Library.

Section 3. That the City Auditor and Comptroller is authorized, upon advice from the Administering Department, to transfer excess funds, if any, to the appropriate reserves.

Section 4. That this activity is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15061(b)(3) because it can be seen with certainty that there is no possibility this activity will result in a direct or reasonably foreseeable indirect physical change in the environment.

Section 5. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 6. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
