WHEREAS, on February 9, 2004, the Council of the City of San Diego authorized the execution of a Joint Use Agreement [JUA] with the San Diego Unified School District for the Pacific Beach Elementary School; and

WHEREAS, the JUA provides for the City to design, construct, operate and maintain approximately 1.8 acres of multi-purpose turfed playing fields on the school site [Project]; and

WHEREAS, on April 26, 2004, the Project was awarded to CDM Construction as the low bidder and construction commenced on June 7, 2004; and

WHEREAS, during construction of the Project unforeseen conditions have resulted in additional costs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the City Auditor and Comptroller is authorized to transfer \$20,000 from CIP No. 29-765.0, Pacific Beach Community Park-Requirements, to CIP No. 29-658.0, Pacific Beach Elementary School Joint Use Improvements, Fund No. 79507, Pacific Beach Developer Impact Fees.
- 2. That the City Auditor and Comptroller is authorized to appropriate and expend \$20,000 from CIP No. 29-658.0, Pacific Beach Elementary School Joint Use Improvements Fund No. 79507, Pacific Beach Developer Impact Fees, to supplement funding previously

authorized to cover additional costs to complete construction of Pacific Beach Elementary
School Joint Use Improvements.

3. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer funds, if any, to the appropriate reserves.
