1. That the Fiscal Year 2005 Capital Improvements Program [CIP] Budget for CIP
No. 61-001.0, Traffic Control and Calming Measures, Fund No. 392109, BCED McMillanMiramar Ranch North Off-Site Roads, is amended by increasing the budget amount by \$75,000.

2. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$75,000 from Fund No. 392109, BCED McMillan-Miramar Ranch North Off-Site Roads to CIP No. 61-001.0, Traffic Control and Calming Measures.

3. That the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$75,000 from CIP No. 61-001.0, Traffic Control and Calming Measures, Fund No. 392109, BCED McMillan-Miramar Ranch North Off-Site Roads, solely and exclusively for the purpose of providing funds for the construction of six electronic speed limit signs in Miramar Ranch North.

4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
