- 5. That an increase in the Fiscal Year 2005 Capital Improvements Program Budget by \$57,000 in CIP No. 29-877.0, Ocean Beach Pier Infrastructure Replacement, Fund No. 630221, Contributions from Fund No. 100, is authorized.

6. That the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$57,000 from CIP No. 29-877.0, Ocean Beach Pier – Infrastructure Replacement, Fund No. 630221, Contributions from Fund No. 100, for the purpose of electrical and sewer infrastructure replacement.
