BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of San Diego Municipal Code section 86.05, the prohibition of the parking or standing of vehicles between the hours of 4:00 p.m. and 7:00 p.m. Monday through Friday (Saturdays, Sundays, and Holidays excepted) on approximately 400 feet of the south side of west San Ysidro Boulevard west of Via De San Ysidro and east of Cottonwood Road is hereby authorized.

BE IT FURTHER RESOLVED, that this parking prohibition on the south side of west San Ysidro Boulevard west of Via De San Ysidro and east of Cottonwood Road is to be enforced as a tow-away zone under the authority of California Vehicle Code section 22651(n) and San Diego Municipal Code sections 81.09 and 86.05.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and the regulations

hereinabove imposed shall become effective upon the installation of such signs.
