WHEREAS, San Diego Municipal Code section 125.1001 et seq. provides a procedure for the summary vacation of public service easements by City Council resolution where the easements are no longer required; and

WHEREAS, the affected property owner has requested the vacation of a portion of the sewer easement to unencumber this property and facilitate development of the site as conditioned in approved Conditional Use Permit No. 127054 and Site Development Permit No. 142713; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the easement, either for the purpose for which it was originally acquired, or for any other public use of a like nature that can be anticipated; and
 - (b) the public will benefit from the vacation through improved utilization of land; and
 - (c) the vacation is consistent with the General Plan or an approved Community Plan; and
- (d) the public service easement for which the easement was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the portion of Easement Abandonment No. 142714 located within the Pacific Beach Community Plan area in connection with Conditional Use Permit No. 127054 and Site Development Permit No. 142713, as more particularly described in the legal description marked

as Exhibit "A," and shown on Drawing No. 20260-B, marked as Exhibit "B," and on file in the office of the City Clerk as Document Nos. RR-300101 -1, and RR-300101 -2, which are by this reference incorporated herein and made a part hereof, is ordered vacated together with a revestment of access rights for Soledad Mountain Road.

- 2. That said easement abandonment is conditioned upon approval and issuance of Conditional use Permit No. 127054 and Site Development Permit No. 142714. In the event this condition is not completed within two years following the adoption of this resolution, then this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the completion of the aforementioned condition and the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.
- 4. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.


