WHEREAS, California Streets and Highways Code section 8330 et seq. and San Diego Municipal Code section 125.1001 et seq. provides a procedure for the summary vacation of public service easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the vacation of a drainage easement within a portion of Pueblo Lot 1119 to unencumber his property and facilitate development of the site; and

WHEREAS, the City Council finds that:

- (c) the vacation is consistent with the General Plan or an approved Community Plan; and
- (d) the public facility or purpose for which the easement was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the drainage easement located within a portion of Pueblo Lot 1119 as more particularly described in the legal description marked as Exhibit "A" and as shown on Drawing No. 20209-B, marked as Exhibit "B," and on file in the office of the City Clerk as Document

Nos. RR-300149, and RR-300149 which are by this reference incorporated herein and made a part hereof, are ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the Office of the County Recorder.



EXHIBIT "A" DRAINAGE EASEMENT VACATION

That portion of Pueblo Lot 1119 of the Pueblo Lands of the City of San Diego made by James Pascoe in 1870, a copy of which said Map was filed in the Office of the County Recorder of San Diego County, November 1, 1921 and is known as Miscellaneous Map No. 36 and as shown on Record of Survey Map No. 6238, recorded May 27, 1963 in the Office of the County Recorder of San Diego County, all in the City of San Diego, County of San Diego, State of California, being more particularly described as follows:

Beginning at the Southwesterly corner of said Record of Survey Map No. 6238, said point being the beginning of a non-tangent 2972.00 foot radius curve concave Northerly, to which a radial line bears South 04°08'58" East; thence along the Southerly line of said Record of Survey Easterly along the arc of said curve through a central angle of 10°15′52" a distance of 532.43 feet; thence continuing along said Southerly line North 75°35′10″ East 97.75 feet to the TRUE POINT OF BEGINNING, said point being on the sideline of that drainage easement to the State of California recorded October 9, 1943 in Book 1573, Page 177 of Official Records, passed to the City of San Diego per Book 2019, Page 96, recorded December 15, 1969 of Official Records; thence leaving said Southerly line along the sideline of said drainage easement North 61°10′50″ West (North 61°42' West, Record) 58.58 feet; thence along the Northwesterly sideline of said drainage easement North 28°49'10" East (North 28°18'00" East, Record) 60.00 feet; thence along the Northeasterly sideline of said drainage easement South 61°10′50″ East (South 61°42′00″ East, Record) 60.18 feet to the Easterly line of Parcel 2 of Document No. 2003-0919887, Recorded July 31, 2003 of Official Records; thence along said Easterly line South 00°13′54″ West (South 00°17′50″ East, Record) 44.05 feet to the Southerly line of said Record of Survey Map No. 6238; thence along said Southerly line South 75°35′10″ West 31.13 feet to the TRUE POINT OF BEGINNING.


