WHEREAS, on August 10, 2004, the City Council adopted Resolution R-299585, which directed the City Manager to issue a Request for Proposal [RFP] to companies in the business of acquiring, refurbishing, upgrading, and delivering one (1) completed Bell 212HP helicopter; and

WHEREAS, in the same vote, the City Council directed the City Manager to return to the City Council with a recommendation to purchase one (1) helicopter from a vendor selected through the City's RFP process utilizing the City's Equipment and Vehicle Financing Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager is authorized to award a contract to Eagle Copters to acquire, inspect, repair as necessary, and deliver one refurbished Bell 212HP fire/rescue helicopter, the form of which is on file in the office of the City Clerk as Document No. RR- $\underline{300167}$ 

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance one Bell 212HP fire/rescue helicopter under the Equipment and Vehicle Financing Program over a period of seven years or by cash funding, in the total principal amount of \$3,992,700, with the intent to reimburse from debt financing in the event the City Council is able to issue appropriate debt financing and exercises its discretion to do so.

BE IT FURTHER RESOLVED, that the City Manager is authorized to expend \$32, 412 for the purpose of hiring three Fire-Rescue helicopter pilots for the final month of Fiscal Year 2005.
