WHEREAS, the City of San Diego retained the firm of KPMG LLP [KPMG] to perform an audit of the City's fiscal year 2003 financial statements, including the financial statements for the Metropolitan Wastewater Utility and Water Utility; and

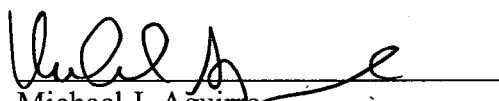
WHEREAS, the contract is currently in an amount not to exceed \$1.7 million; and

WHEREAS, pursuant to accounting standards and practices, the City needs to continue to conduct additional investigations; and

WHEREAS, the City has been working with KPMG on the scope of the additional investigations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager is authorized and directed to execute a Fourth Amendment to the Retention Agreement with KPMG for an additional amount not to exceed \$500,000, for a total contract amount not to exceed \$2.2 million.
