PROCLAMATION OF A LOCAL  
EMERGENCY

WHEREAS, pursuant to San Diego Municipal Code Section 51.0106(a)(1) the City Manager is authorized to proclaim the existence of a local emergency when the City Council is not in session; and

WHEREAS, such declaration by the City Manager remains in effect for a period not to exceed seven days unless the City Council ratifies the declaration, in which case the declaration remains in effect until terminated by the City Council; and

WHEREAS, on February 24, 2005, the City Manager declared a state of emergency pursuant to his powers under the Municipal Code, a copy of which declaration is attached as Exhibit A; and

WHEREAS, as set forth in the declaration by the City Manager conditions of extreme peril to the safety of persons and property have arisen within the City of San Diego as a result of a series of winter storms which began at approximately 5:00 a.m., February 17, 2005, and continue to directly affect the safety of person and property within this city; and

WHEREAS, the conditions of extreme peril warrant and necessitate the proclamation of a local emergency; and

WHEREAS, it is now necessary and appropriate for the City Council to ratify the declaration of the state of emergency; NOW, THEREFORE,


BE IT RESOLVED by the Council of the City of San Diego that a local emergency currently exists, and has existed since February 17, 2005, throughout the City of San Diego and shall be deemed to continue to exist until its termination is proclaimed by the City Council.

BE IT FURTHER RESOLVED that a copy of this proclamation be forwarded to the Governor of California with the request that he proclaim the City of San Diego to be in a State of Emergency; and further that the Governor request a Presidential Declaration.

BE IT FURTHER RESOLVED that during the existence of this local emergency the powers, functions and duties of the City Manager of this City shall be those prescribed by State law and the Charter, ordinances, resolutions and approved plans of the City of San Diego in order to mitigate the effects of this local emergency, including the receipt, processing, and coordination of all inquiries and requirements necessary to obtain available state and federal assistance.

PROCLAMATION OF A LOCAL EMERGENCY  
BY THE CITY MANAGER

WHEREAS, pursuant to San Diego Municipal Code Section 51.0106(a)(1) the City Manager is authorized to proclaim the existence of a local emergency when the City Council is not in session; and

WHEREAS, conditions of extreme peril to the safety of persons and property have arisen within the City of San Diego as a result of a series of winter storms which began at approximately 5:00 a.m., February 17, 2005, and continue to directly affect the safety of person and property within this city; and

WHEREAS, the conditions of extreme peril warrant and necessitate the proclamation of a local emergency; NOW, THEREFORE,

IT IS HEREBY PROCLAIMED that a local emergency currently exists, and has existed since February 17, 2005, throughout the City of San Diego and shall be deemed to continue to exist for seven days unless ratified by the City Council, and then until its termination is proclaimed by the City Council of the City of San Diego.


IT IS FURTHER PROCLAIMED AND REQUESTED that a copy of this proclamation be forwarded to the Governor of California with the request that he proclaim the City of San Diego to be in a State of Emergency; and further that the Governor request a Presidential Declaration.

IT IS FURTHER PROCLAIMED AND ORDERED that during the existence of this local emergency, the powers, functions and duties of the City Manager of this City shall be those prescribed by State law and the Charter, ordinances, resolutions and approved plans of the City of San Diego in order to mitigate the effects of this local emergency, including the receipt,

processing, and coordination of all inquiries and requirements necessary to obtain available state and federal assistance.

IT IS FURTHER PROCLAIMED AND ORDERED that a state of local emergency shall be deemed to continue to exist for the next seven days unless ratified by the City Council, and then until its termination is proclaimed by the City Council of the City of San Diego.


