WHEREAS, beginning in 1998, the San Diego City Attorney's Office undertook a project designated the "Elder Abuse and Same Sex Domestic Violence Program" (the "project") funded in part from funds made available through the "Violence Against Women Vertical Prosecution Program" administered by the State of California Office of Criminal Justice Planning ("OCJP"); and

WHEREAS, the City Attorney's Office has continued and desires to continue to undertake the project; and

WHEREAS, in November 2003, the City Attorney's Office received notification from the OCJP that the City of San Diego ("City") had been awarded a grant for the project in the amount of \$34,703 for the period from July 1, 2003, to September 30, 2003; and

WHEREAS, as a result of budget constraints, the OCJP was eliminated and its grants and projects were transferred to the State of California Office of Emergency Services ("OES"); and

WHEREAS, in January 2004, the City Attorney's Office received notification from the OES that the City had been awarded a grant in the amount of \$104,109 for the period from October 1, 2003, through June 30, 2004; and

WHEREAS, in January 2005, the City Attorney's Office received notification from the OES that the City had been awarded a grant in the amount of \$115,645 for Fiscal Year 2005 (July 1, 2004, through June 30, 2005); and

WHEREAS, these grants require a twenty five percent (25%) match by the City which has and will be met through existing staff salaries; and

WHEREAS, the project will continue to attend to the Elder Abuse and Same Sex Domestic Violence Program in the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the San Diego City Attorney, or his duly designated representative, is authorized, for and on behalf of the City, to apply for grant funding for the Elder Abuse and Same Sex Domestic Violence Program.
- 2. That the San Diego City Attorney, or his duly designated representative, is authorized, for and on behalf of the City, to take all necessary steps to secure the grants.
- 3. That the San Diego City Attorney, or his duly designated representative, is authorized, for and on behalf of the City, to execute and submit all documents necessary to comply with the grant requirements.
- 4. That the San Diego City Attorney, or his duly designated representative, is authorized, for and on behalf of the City, to accept, appropriate, expend, and administer the grant funds, if and when secured, in accordance with the terms and conditions of the grant program.
- 5. That the San Diego City Attorney, or his duly designated representative, is authorized, for and on behalf of the City, to accept the following grant amounts for the Elder Abuse and Same Sex Domestic Violence Program for the periods indicated and as more particularly described in the documents listed as filed in the Office of the City Clerk:
- a. \$34,703 for the period from July 1, 2003, to September 30, 2003, as more particularly described in the document on file in the Office of the City Clerk as Document No. RR-300272-;

- b. \$104,109 for the period from October 1, 2003, through June 30, 2004, as more particularly described in the document on file in the Office of the City Clerk as Document No. RR-300272; and
- c. \$115,645 for Fiscal Year 2005 (July 1, 2004, through June 30, 2005), as more particularly described in the document on file in the Office of the City Clerk as Document No. RR-300272-3

BE IT FURTHER RESOLVED, that pursuant to the terms and conditions of the grant program:

- 1. The City is authorized to appropriate all matching funds required for the project, including any amendments thereof.
- 2. Any liability arising out of the City's performance under these grants, including civil court actions for damages, shall be the responsibility of the City.
- 3. All funds received pursuant to these grants shall be spent exclusively for the project and shall not be used to supplant expenditures controlled by the City Council.
