BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of San Diego Municipal Code section 85.04, the prohibition of commercial vehicles with a rated capacity of five (5) tons or more from using the following streets is hereby authorized: 26<sup>th</sup> Street from Main Street to Logan Avenue, 27<sup>th</sup> Street from Main Street to National Avenue, Sicard Street from Main Street to National Avenue, Sampson Street from Main Street to Logan Avenue, Julian Avenue from Cesar Chavez Parkway to Commercial Street, Irving Avenue from Cesar Chavez Parkway to Commercial Street, Main Street from Cesar Chavez Parkway to Sampson Street and Cesar Chavez Parkway from Harbor Drive to Commercial Street.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said streets, and the regulations hereinabove

imposed shall become effective upon the installation of such signs.
