A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF AN ASSIGNMENT, ASSUMPTION AND CONSENT AGREEMENT ASSIGNING THE SAN DIEGO REGIONAL TECHNOLOGY ALLIANCE'S OBLIGATIONS AND INTERESTS UNDER THAT CERTAIN ECONOMIC DEVELOPMENT AND TOURISM SUPPORT PROGRAM AGREEMENT TO THE SAN DIEGO WORK FORCE PARTNERSHIP.

WHEREAS, in FY 2005, the City entered into that certain Economic Development and Tourism Support Program Agreement [Program Agreement], dated as of October 15, 2004, by and between the City of San Diego [City], and the San Diego Regional Technology Alliance [RTA], pursuant to which the RTA was to provide workforce development activities; and

WHEREAS, pursuant to the Program Agreement, the RTA was specifically required to compile a resource guide to be used by Community Technology Center directors and to provide employment resource consulting to ten of the City's Community Technology Centers; and

WHEREAS, the RTA completed the Community Technology Centers' resource guide but has since lost a large portion of its funding from the State of California and as a result has had to reorganize to become the RTA@CONNECT; and

WHEREAS, the RTA@CONNECT is unable to provide the employment resource consulting as required under the Program Agreement; and

WHEREAS, the San Diego Workforce Partnership [SDWP] has the ability to, and interest in providing the remaining services under the Program Agreement; and

WHEREAS, the RTA desires to assign its obligations and interests under the Program

Agreement to the SDWP and the SDWP desires to accept such assignment; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager or Designee is authorized and empowered to execute an Assignment, Assumption and Consent Agreement, by and among the RTA, the SDWP and the City for the purpose of assigning the remaining obligations and interests of the RTA under the Program Agreement to the SDWP. A copy of the Assignment, Assumption and Consent Agreement is on file in the office of the City Clerk as Document No. RR- 300325.
