A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO MAKING CERTAIN DETERMINATIONS AND FINDINGS PURSUANT TO HEALTH AND SAFETY CODE SECTION 33445 AND CONSENTING TO THE AGENCY ASSISTING IN THE FUNDING OF THE CONSTRUCTION OF THE NEW DOWNTOWN MAIN LIBRARY.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to execute and implement the Redevelopment Plan, as amended and supplemented from time to time, for the Centre City Redevelopment Project [Project]; and

WHEREAS, pursuant to Section 33445(a) of the California Community Redevelopment Law (Cal. Health & Safety Code § 33000 et seq.) [Redevelopment Law], the Agency may, with the consent of the City Council [City Council] of the City of San Diego [City], pay all or a part of the value of the land for and the cost of the installation and construction of any building, facility, structure, or other improvement which is publicly owned either within or outside a project area, if the City Council makes certain determinations; and

WHEREAS, the Agency is considering the use of tax increment from the Project to assist with the funding of a new downtown main library to be located on the block bounded by 11<sup>th</sup> Avenue, Park Boulevard, "J" Street on the north and Park Boulevard to the South [Library]; and

WHEREAS, the Library will be located within the Project and will be publicly owned; and

WHEREAS, the Agency has prepared a report pursuant to Redevelopment Law Section 33679 [Report]; and

WHEREAS, all other legal prerequisites to the adoption of this Resolution have occurred; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- The City Council hereby finds and determines that the foregoing recitals are true and correct.
- 2. Based on substantial evidence in the record, including, without limitation, the information contained in the Report, the City Council hereby finds and determines that:
  - a. The Library is of benefit to the Project or the immediate neighborhood in which the Library is located;
  - No other reasonable means of financing the Library are available to the
     City; and
  - c. The payment of funds by the Agency for the costs related to the Library will assist in the elimination of one or more blighting conditions within the Project and is consistent with the Project's Five-Year Implementation Plan.
- 3. That the City Council hereby consents to the Agency assisting in the funding of the construction of the Library.

4. That the City Manager is authorized to take any action and execute any and all documents and agreements necessary to implement this Resolution.
