WHEREAS, California Streets and Highways Code section 8330 et seq. and San Diego Municipal Code section 125.1001 et seq. provides a procedure for the summary vacation of public service easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the vacation of a sewer easement in Lots 17, 18 and 19, Block 2 of Nicholson's Addition Map No. 952 to unencumber his property and facilitate development of the site; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the sewer easement, either for the purpose for which it was originally acquired, or for any other public use of a like nature that can be anticipated; and
 - (b) the public will benefit from the vacation through improved utilization of land; and
 - (c) the vacation is consistent with the General Plan or an approved Community Plan; and
- (d) the public facility or purpose for which the easement was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the sewer easement located within Lots 17, 18 and 19, Block 2 of Nicholson's Addition Map No. 952 as more particularly described in the legal description

marked as Exhibit "A" and as shown on Drawing No. 20153-B, marked as Exhibit "B," and on file in the office of the City Clerk as document Nos. RR - 300374 -/, and

RR - 300374⁻², which are by this reference incorporated herein and made a part hereof, are ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the Office of the County Recorder.


