WHEREAS, California Streets and Highway Code Section 8330 et seq. and San Diego Municipal Code section 125.0901 et seq. provides a procedure for the summary vacation of public street easements by City Council resolution where the easements are no longer required; and

WHEREAS, the affected property owner has requested the vacation of the public street easement to unencumber this property; and

WHEREAS, at a prior hearing the owner has agreed to relinquish his access rights from the adjacent Egret Street; and

 - (b) the public will benefit from the vacation through improved utilization of land; and
 - (c) the vacation is consistent with the General Plan or an approved Community Plan; and
- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That portion of 60th Street, including the relinquishment of access rights from Egret Street, as described in the legal description marked as Exhibit "A," and as more particularly

shown on Drawing 20125-B, labeled Exhibit "B," on file in the office of the City Clerk as

Documents No. RR300417 and RR-300417 which are by reference incorporated herein and made part hereof, is ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits attested by him under seal, to be recorded in the office of the County Recorder.
