## RESOLUTION NUMBER R- 300423 ADOPTED ON MAY 1 0 2005

WHEREAS, pursuant to resolution number R-300139, adopted on February 14, 2005, the City Council authorized and directed that the Mayor, the City Manager, and the City Attorney execute an engagement agreement with Kroll Associates, Inc. ("Kroll") in connection with matters involving the San Diego City Employees' Retirement System; and

WHEREAS, the Kroll engagement letter has been duly signed and acknowledged by the Mayor, the City Manager, and the City Attorney; and

WHEREAS, the Kroll engagement letter provides that Kroll may in its discretion retain legal counsel in connection with its work; and

WHEREAS, pursuant to resolution number R-300203, adopted on March 8, 2005, the City Council, in order for the City of San Diego to achieve the full benefit of Kroll's work, established an Audit Committee of the City of San Diego (the "Audit Committee") as contemplated by the Sarbanes-Oxley Act of 2002; and

WHEREAS, the Sarbanes-Oxley Act of 2002 contemplates that audit committees shall be empowered to engage advisers with appropriate funding being provided "as determined by the audit committee"; and

WHEREAS, the Audit Committee proposes to engage Willkie Farr & Gallagher LLP to serve as its counsel; and

WHEREAS, additional funds also are necessary for the continued services of the Audit Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Audit Committee's Status Report, provided verbally at the Council meeting, is hereby accepted.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to the Agreement with Kroll Inc., for an additional amount not to exceed \$1,500,000, for continued provision of investigative services in their role as the City's Audit Committee, and consulting assistance in assessing internal control deficiencies affecting matters discussed in the Vinson & Elkins and City Attorney investigation reports, for a total contract amount not to exceed \$1,750,000.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Agreement with Willkie, Farr & Gallagher LLP, in an amount not to exceed \$500,000, for provision of independent legal counsel to the City Audit Committee and Kroll in connection with the above matters.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,200,000 from Fund No. 81140, Dept. No. 82240, Object Account No. 4151, Job Order No. 082240; \$400,000 from Fund No. 41506, Dept. No. 776, Org. No 445, Object Account No. 4222, Job Order No. 776260; and \$400,000 from Fund No. 41500, Dept. No. 760, Org. No. 163, Object Account No. 4151, Job Order 000163 is hereby authorized, solely and exclusively for the purpose of providing funds for the above agreements.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
