

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend \$30,000 from CIP 52-724.0, Safe Routes to School—Gompers and Horton, Fund 30300, TransNet, for construction of additional school traffic safety improvements, contingent upon the City Auditor and Comptroller certifying that the necessary funds are on deposit in the City Treasury;

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserves.
