"A," and as shown on Engineering Drawing No. 20269-B, marked as Exhibit "B," on file in the office of the City Clerk as Document Nos. RR- 300492, and RR- 300492, which are by this reference incorporated herein and made a part hereof, is ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.
