RESOLUTION NUMBER R- 300570 ADOPTED ON JUN 2 1 2005

A RESOLUTION ESTABLISHING UNDERGROUND UTILITY DISTRICTS FINANCED THROUGH THE SAN DIEGO GAS & ELECTRIC UNDERGROUNDING SURCHARGE FUND.

WHEREAS, by Resolution No. R-300341, a public hearing was called for on 10005, 2005, at the hour of 10000 m, in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, to determine whether the public health, safety, or general welfare requires the removal of poles, overhead wires, and associated structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within certain areas of the City of San Diego more particularly described as follows [the Districts]:

- District 1, Block 1-R, as described in Exhibit A, to this resolution and more particularly shown on Drawing No. 33491-1-D, and
- District 4, Block 4-AA, as described in Exhibit B, to this resolution and more particularly shown on Drawing No. 33494-1-D, and
- District 6, Block 6-J, as described in Exhibit C, to this resolution and more particularly shown on Drawing No. 33495-1-D, and
- Ridge Manor Drive from Madra Drive to Del Paseo Avenue, as described in
 Exhibit D, to this resolution and more particularly shown on Drawing No. 335561-D, and

Ridgemoor Drive from Overlake Drive to Crystalaire Drive, as described in
Exhibit E, to this resolution and more particularly shown on Drawing No. 335571-D, and

WHEREAS, notice of such hearing has been given by the City Manager to all affected property owners as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and the utilities concerned in the manner and for the time required by law; and

WHEREAS, such hearing has been duly and regularly held and all persons interested have been given an opportunity to be heard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. The City Council hereby finds and determines that the public health, safety, or general welfare requires the removal of poles, overhead wires, and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within the areas set forth above and that pursuant to Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, the above areas are hereby declared to be underground utility districts in the City of San Diego, and the maps and document referred to above are hereby incorporated as a part of this resolution.
- 2. The City Manager is hereby authorized to establish schedules for the underground conversion of all poles, overhead wires, and associates structures in each District.
- 3. The City Manager is hereby instructed to notify all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and all affected utility companies of the adoption of this resolution within fifteen days after date of adoption. The City Manager shall further notify affected persons as defined in Chapter VI, Article 1, Division 5 of

the San Diego Municipal Code of the necessity that if they desire to continue to receive electric, communication, community antenna television or similar or associated service, they shall permit the installation of all necessary facility changes on their premises, or provide such changes at their own expense, so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations, and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California (as of the date of the adoption of this resolution) and subject to all other applicable requirements of State law and City ordinances. The City Manager's notification shall be in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.



Lots 113, Lots 115 thru 184 of SAN CARLOS ESTATES UNIT No.9, Map No. 4955

Said district shall also include the following public rights-of-way.

RIDGEMOOR DRIVE between a line parallel to and +/- 95 feet of north of CRYSTALAIRE DRIVE to the southerly end of RIDGEMOOR DRIVE.

OVERLAKE AVENUE between a line parallel to and +/- 70 feet of northwest of GLENLEA LANE to the southerly end of OVERLAKE AVENUE.

CRYSTALAIRE DRIVE between a line parallel to and +/- 70 feet of west of RIDGEMOOR DRIVE.

GLENLEA LANE between a northeast line of RIDGEMOOR DRIVE to a southwest line of OVERLAKE AVENUE.
