RESOLUTION NUMBER R- 300579 ADOPTED ON JUN 2 7 2005

A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY MANAGER TO PROCEED WITH AN EXCLUSIVE NEGOTIATING AGREEMENT WITH SIMPLON BALLPARK, LLC, FOR THE PROPOSED CONSTRUCTION OF A NEW FIRE STATION LOCATED IN THE DOWNTOWN AREA AND ACCEPTING A GOOD FAITH DEPOSIT TO PAY FOR ADMINISTRATIVE EXPENSES INCURRED BY THE CITY DURING NEGOTIATIONS.

WHEREAS, the City of San Diego (CITY) owns a functioning fire station (Fire Station No. 4) which is located at the northwest corner of 8th Avenue and J Street, approximately one block north of Petco Park; and

WHEREAS, Simplon Ballpark, LLC (SIMPLON) would like to acquire the existing fire station site for inclusion into a mixed-use project of retail, office, and high-rise condominiums to be known as Cosmopolitan Square; and

WHEREAS, SIMPLON is offering to replace the existing fire station with a new, larger facility, one lot to the north of the existing fire station. The existing fire station is a two-story, 7,120 square foot cast-concrete structure built in 1937, situated on a 5,000 square foot lot. The proposed new fire station is contemplated to be an approximate 13,190 square foot two-story structure with underground parking; and

WHEREAS, the proposed project will provide the City with a state-of-the-art fire facility that will be able to meet the needs of the continued growth of the downtown area; and

WHEREAS, the City Manager has recommended that the City Council approve an Exclusive Negotiating Agreement [ENA] to commence exclusive negotiations with SIMPLON regarding the new fire station; and

WHEREAS, the terms of the ENA require that SIMPLON submit a good faith deposit of \$10,000 to offset a portion of the CITY's staff costs, consultant costs and other administrative costs incurred by the CITY in negotiating, preparing and processing the proposed purchase and sale agreement; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the City Manager, or his designee, is authorized and empowered to execute, for and on behalf of the CITY, an ENA with SIMPLON, for the proposed construction of a new fire station, under the terms and conditions set forth in the ENA on file in the office of the City Clerk as Document No ______.
- 2. That the fiscal year 2005 CIP budget shall be amended to add CIP No. 33-510.0, Fire Station No. 4.
- 3. That the City Manager, or his designee, is authorized to accept from SIMPLON the sum of \$10,000 and deposit it into Fund No. 63022, Trust Fund for Development, to be used to offset a portion of the CITY's staff costs, consultant costs and other administrative costs incurred by the CITY in negotiating, preparing and processing the proposed purchase and sale agreement.
- 4. That the Auditor and Comptroller are authorized to appropriate and expend \$10,000 from Fund No. 63022, Trust Fund for Development, into CIP No. 33-510.0, Fire Station No. 4, contingent on the funds being received from SIMPLON and provided that the City
