Shira, Tom Story, Shalonda Vinegar, Bruce Williams, Colleen Windsor and Robert Young; and


WHEREAS, over the years, the Mayor's staff has become a family as they together celebrated births, birthdays, wedding engagements, and mourned deaths; and
